**RULES AND REGULATIONS**

1. The entry fee is two hundred fifty dollars (\$250).
2. Maximum five (5) entries per person.
3. **Deadline for entry is Saturday, September 10th, 2011 at 8:00 p.m.**
4. Leroy's Pro Challenge requires the entrant to pick Five (5) pro football games per week from the Pro Challenge card. All point spreads are half points.
5. The total number of wins accumulated on the selected games during the Challenge will determine the Challenge winners. Each winning selection will be credited as one win.
6. The Challenge will consist of 17 weeks from September 10th through February 5th, 2012 (Sunday and Monday games only).
7. Leroy's will payout 100% of entry fees. Actual cash prizes will be dependent on the number of entrants. Percentages do not change. The sample payouts listed below are based on 400 entrants.

10. **Entrants must submit their weekly selections to any Leroy's sports book location by 9:00 p.m. every Saturday for the following Sunday and Monday games.** This deadline will be strictly enforced. Any entrant who fails to submit weekly selections will be awarded zero wins for that week. Leroy's recommends submitting selections as early as possible. 13. Any individual entry submitted with the wrong entrant number will be disqualified for that week and will be awarded zero wins for that week's selections. It is the sole responsibility of the entrant to provide and maintain their entrant number.
14. Each entrant may specify an alias for Leroy's use on the web and in print for standings and weekly selection displays. Alias is limited to 14 digits. Leroy's reserves the right to approve any and all aliases.
15. All entrants and proxies must be at least 21 years old.
