**WINNER TAKE ALL
ELIMINATION PRO FOOTBALL CONTEST
Full Season Contest Starts September 11th**

RULES AND REGULATIONS

1. The entry fee is twenty-five dollars (\$25). Maximum of five (5) entries per person. Any entrant with more than five entries will be disqualified.
2. Deadline for entry is Saturday, September 10th, 2011 at 8:00 p.m.
3. All entrants and proxies must be at least 21 years old
4. Three 'n' Out elimination pro football contest requires the entrant to select one professional football side or total per week from the Three & Out contest lines. There will not be any ties due to all point spreads being half points.
5. Three 'n' Out is an elimination style contest where entrants will be eliminated when an entrant does not select a winning side or total three times. The winner will be determined when all but one entrant have been eliminated. If all remaining entrants are eliminated the same week those entrants will be declared the winners and the prize money will be equally split. If, after the final championship game, there is more than one remaining entrant, the prizes will be paid as follows:
 - If the entrant with the least amount of losses has 0 losses then,
 - Entrants(s) with 0 losses will receive 70% of the prize pool
 - Entrants(s) with 1 loss will receive 20% of the prize pool
 - Entrants(s) with 2 losses will receive 10% of the prize pool
 - If the entrant with the least amount of losses has 1 loss then
 - Entrants(s) with 1 loss will receive 70% of the prize pool
 - Entrants(s) with 2 losses will receive 30% of the prize pool
 - If the entrant with the least amount of losses has 2 losses then
 - Entrants(s) with 2 losses will receive 100% of the prize pool
6. Three 'n' Out will consist of a maximum of 21 weeks from September 11th, 2011 through February 5th, 2012.
7. Leroy's will payout 100% of entry fees to the winner(s). Actual cash prize(s) will be dependent on the number of entrants.
8. Entrants must submit their weekly selections to any Leroy's sports book location by the kickoff of the game the entrant is selecting. Any entrant who fails to submit a weekly selection will receive a loss for that week's selection. Only one selection accepted per entrant ID per week.
9. In the eventuality of a game cancellation or date change game must be played by the following Tuesday to be considered action or entrant will receive a loss for that week's selection. Time changes are action. Site changes are action.
10. It is the entrant's responsibility to correctly fill out and turn in weekly selections properly. The entrant will then receive a computer generated ticket. Only selections on the computer generated ticket and recorded in Leroy's server will be valid as official selections. The card marked by the entrant that produces the contest ticket has no value and is not valid for winning any prize.
11. Any individual entry submitted with the wrong entrant number will be disqualified for that week and will be awarded a loss for that week's selections. It is the sole responsibility of the entrant to provide and maintain their entrant number.
12. Each entrant may specify an alias for Leroy's use on the web and in print for weekly standings and selection displays. Alias is limited to 14 digits. Leroy's reserves the right to approve any and all aliases.
13. Last four digits of entrants Social Security number are required for verification purposes. All winners of a prize will be required to provide photo ID in person and their full Social Security number at time of payment. Any taxes or fees are the sole responsibility of the entrant.
14. By entering the contest, entrant grants permission to Leroy's to use his or her name or alias and photograph for publicity purposes.
15. After the final winner(s) is determined, there will be a seven-day verification period. At the end of this period, the contest results will be declared official and the winner(s) will be paid.
16. In the event of a dispute, the decision of Nevada Gaming Control Board and / or Commission is final.
